1. To retroactively adopt and approve the appropriations contained in Exhibit "A", hereto attached and made a part hereof. The purpose of this legislation is for reconciliation of the 2020 Budget.
2. Authorizing the Board of Control of the City of Youngstown to approve the purchase of four (4) touchless hand-washing stations in an amount not to exceed \$48,000.00 from Personal Protected.
3. Authorizing the Board of Control of the City of Youngstown to accept the COVID-19 CR21 Grant in the amount of \$225,195.00. Further, to authorize the Board of Control of the City of Youngstown to enter into any necessary professional service
