

CITY COUNCIL REORGANIZATION MEETING
TUESDAY, JANUARY 2, 2024, 8:00 P.M.

CITY COUNCIL CONVENED IN A REORGANIZATION SESSION AND WAS CALLED TO ORDER BY PRESIDENT THOMAS HETRICK. 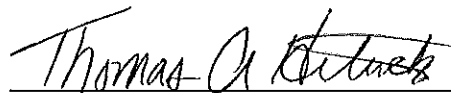
