KNOWN ALL MEN BY THESE PRESENTS: That (Contractor) _____
as Principal, and the _____, as Surety, are held and firmly bound
unto the City of Youngstown, Ohio or to any of its officers, agents, or employees, for the use of any persons, firms,
corporations with whom such Principal shall contract to do work in the construction, erection, framing, installation,
remodeling, repairing, setting, replacing, alteration, demolition, conversion or moving of dwelling houses, garages,
barns, sheds, or shelters; commercial, industrial or public buildings or structures or parts thereof; public or commercial
recreational buildings, structures or areas or parts thereof; and all appurtenant buildings, structures or areas of any of the
foregoing in accordance with the provisions and requirements of the ordinances of the City of Youngstown, Ohio in the
penal sum of TEN THOUSAND DOLLARS (\$10,000.00), lawful money of the United States, for the payment of which
sum well and truly to be made, we bind ourselves, our heirs, executors, administrators, successors and assigns, jointly,
severally, firmly by these presents.

THE CONDITIONS OF THE ABOVE OBLIGATION ARE SUCH, that whereas the above named Principal has made
application with the City of Youngstown for registration as a specialty contractor as defined in 01-394 of the Codified
Ordinances of the City of Youngstown, Ohio to engage in the business of construction, erection, framing, installation,
remodeling, repairing, setting, replacing, alteration, demolition, conversion of moving of dwelling houses, garages,
barns, sheds or shelters; commercial, industrial or public buildings or structures or part thereof; public or commercial
recreational buildings, structures or areas or parts thereof; and all appurtenant buildings, structures or areas of any of the
foregoing in accordance with the provisions and requirements of the ordinances of the City of Youngstown, Ohio during
the term beginning, _____ 20_____, and ending December 31, 20_____.

NOW THEREFORE, if the said Principal shall well and truly indemnify; keep and save harmless the City of
Youngstown, Ohio or any of its officers, agents, or employees for the use of any persons, firms or corporations with
whom such Principal shall contract to do work, and shall indemnify and pay any such persons, firms or corporations for
damages sustained on account of the failure of such Principal, his agents, subcontractors or employees to well and
faithfully perform the work so contracted for in accordance with the provisions of the building code and other ordinances
of the City of Youngstown, any amendments thereto, and any and all lawful rules and regulations promulgated under the
authority thereof, and from or by reason or on account of anything done under and by virtue of any permits issued under
such registration for the doing of any work required to be done in the construction, erection, framing, installation,
remodeling, repairing, setting, replacing, alteration, demolition, conversion or moving of dwelling houses, garages,
barns, sheds, or shelters; commercial, industrial or public buildings or structures or parts thereof; public or commercial
recreational buildings, structures or areas or parts thereof; and all appurtenant buildings, structures or areas of any of the
foregoing, then this obligation shall be null and void; otherwise to remain in full force and effect.
