## YOUNGSTOWN PARK RULES AND REGULATIONS

EVERY PERSON USING THE PARKS OR PLAYGROUNDS SHALL BE SUBJECT TO THESE RULES AND REGULATIONS ADOPTED BY THE MAYOR BASED UPON THE RECOMMENDATION OF THE DIRECTOR OF PARKS & RECREATION FOR PUBLIC SAFETY, THE PROTECTION OF PROPERTY AND MAINTENANCE OF ORDER WITHIN THE PUBLIC PARKS AND PLAYGROUNDS.

1. Parks will be open dawn to dusk. Unless a permit has been issued that allows for extended use, no person, except authorized employees, shall remain in or enter the parks between dusk and dawn.
2. No person shall injure or deface any trees, plant, grass or structures.
3. Gambling, drunkenness, disorderly or indecent conduct, profane or offensive language is prohibited in all parks and playgrounds.
4. Alcoholic beverages may not be used or brought into any park or playground at any time.
5. Public meetings, speeches, parades or like gatherings, may not take place within the limits of the parks and playground without a permit from the Parks & Recreation Department.
6. Fires are not permitted anywhere in parks or playgrounds, except in designated places.
7. Games, contests and sports are permitted only in designated areas.
8. Dogs are not permitted anywhere in parks or playgrounds, except when held on a leash and under control of the owner or person walking such dog. All animal waste must be picked up by owner.

9. Swimming is permitted only in designated pools. Swimmers must be properly clothed.
10. No person shall recklessly cause inconvenience, annoyance, or alarm to another, by doing any of the following: Engaging in fighting; Make threats to harm persons or property; Act in a violent or turbulent manner; Make insulting, taunting, or challenging statements, under circumstances in which such conduct is likely to provoke a violent response.
11. One may not restrain the movement of another within the park.
12. No person shall create a condition which is physically offensive to persons or which presents a risk of physical harm to persons or property, by an act which serves no lawful and reasonable purpose of the offender.
13. No person, except park police and private security, shall carry firearms, tasers or mace.
14. No unauthorized motor vehicles, snowmobiles, all-terrain vehicles, dirt bikes, aircraft, or drones shall be used on City of Youngstown park property. Licensed motor vehicles may be driven on marked parking lots and roads.
15. No person shall sell any item on park property without the permission of the Director of Parks & Recreation.
16. No person shall solicit contributions for any purpose on park property without the permission of the Director of Parks & Recreation.
17. No person shall collect admission to any event on park property without the permission of the Director of Parks & Recreation or an appropriate permit.
18. Persons using park facilities with a permit shall have priority over persons using facilities without a permit.
19. No tape is permitted on walls or other painted surfaces within the park.
20. No sound amplification devices are permitted on park property without a permit/security agreement from the park office. Contact the Park Office at 330.742.8711 for details.
21. Seasonal team and organization permits are available for designated fields and parks. Contact the Park Office at 330.742.8711 for details.
22. Parks and recreational facilities specific rules must be followed as more fully indicated in the charts below.
23. The City of Youngstown Parks and Recreation Department reserves the right to alter or amend these rules at any time.

## PARKS AND RECREATIONAL FACILITIES

Facilities at City parks may be reserved in accordance with the rates and procedures described below. To make a reservation for any park facility, contact 330-742-8711. All reservations shall be made on a first come first serve basis, with the exception of activities organized by the Parks Department which shall have scheduling priority.
